#### E-file Threshold Change

Proposed IRS regulations were recently released recommending that the e-file threshold for information returns be lowered from 250 to 100 for Tax Year 2021. This new regulation includes the total for all aggregated forms filed.

- Taxpayer First Act allows IRS / SSA to lower threshold:
  - Most likely dropping to 100 for Tax Year 2021 returns
  - Allowed to drop to 10 for Tax Year 2022
  - Formal regulations released (pending final approval)

#### E-file Threshold Change

The e-file threshold would no longer apply per form type, but rather filers that have a **combined total of 100 or more** information returns would be required to electronically file all information returns.

#### Example:

65 W-2's

**53** 1095-C Forms

+ 10 1099 Forms

118 total Forms = E-file required for ALL form types



## Before E-filing

- Check that your information is accurate!
- Run an Edit Report for both 1099's and w-2's and verify ...
  - Name
  - Address
  - Social Security or EIN
  - Wages/Non-Employee Compensation Amounts
  - Taxes (State and Local if applicable)
- We've included a Help Document if you find you need to make any changes before E-filing.

#### How to run a 1099 Edit Report

- Accounts Payable > Reports > 1099
- Most customers will use Type NEC (Non-Employee Compensation).
- Enter as shown.
- Click Run Report.







- Click Run Report.







- To check on previously submitted E-Filings, click the Check Filing Status link.


